## In breach of

Contrary to Core Duty 5 of the Bar Standards Board Handbook (1<sup>st</sup> Edition).

## Details of Offence

Ian Millard, an unregistered barrister, on the 21<sup>st</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "Two cab drivers guilty of refusing to pick up blind man and guide dog". Muslims again. Wake up, UK!

Ian Millard, an unregistered barrister, on the 21<sup>st</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "Pro-Zionist, pro-Jew expenses cheat Michael Gove, now diminished shrunk to his true level (2 inches off the ground). Liar."

Ian Millard, an unregistered barrister, on the 30<sup>th</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "@HeretoWhiteMan thank you. When one looks at that little Jew, one has to wonder what the French people saw in him, as he gesticulates etc."

Ian Millard, an unregistered barrister, on the 21<sup>st</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it depicted a swastika and the words "Juden sind hier unerwünscht" the English translation of which is "Jews unwanted [or not wanted] here."

Ian Millard, an unregistered barrister, on the 23<sup>rd</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "A million British people forced to use foodbanks and all the Jew Shapps can say is to parrot a list of hackneyed propaganda phrases."

Ian Millard, an unregistered barrister, on the 24<sup>th</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "Strange seeing Dominic Grieve, who reminds me of the days when many/most Conservative MPs were English gentlemen, not Jews or yobs."

Ian Millard, an unregistered barrister, on the 29<sup>th</sup> November 2014 posted a tweet on Twitter (having previously identified himself on Twitter as a barrister) which was seriously offensive and was likely to diminish the trust and confidence which the public places in Mr Millard or in the profession in that it stated "So-called \*Black Friday is just that in the UK. 95% blacks and browns, with the odd white chavscum here and there. UK finished?"

**SENTENCE:** Disbarred.

**STATUS:** Final.
