Paragraphs 301[a][i], 301[a][ii], 301[][iii] and pursuant to paragraph 901.7 of the Code of Conduct of the Bar of England and Wales [8th Edition] and Core Duty 9 and Rules rC65.1 and rC65.2 of the Bar Standards Board Handbook.

Details of offence:

Mr Uddin, an unregistered barrister, engaged in conduct which was dishonest or otherwise discreditable to a barrister, in that between 2010 and 2013 he conspired to defraud by supplying false documentation to a number of people for the purposes of obtaining visas from the Home Office, for which conduct on the 16 November 2018 he was convicted at Southwark Crown Court and sentenced to 30 months imprisonment.

Mr Uddin, an unregistered barrister, engaged in conduct which was prejudicial to the administration of justice, in that between 2010 and 2013 he conspired to defraud by supplying false documentation to a number of people for the purposes of obtaining visas from the Home Office, for which conduct on the 16 November 2018 he was convicted at Southwark Crown Court and sentenced to 30 months imprisonment.

Mr Uddin, an unregistered barrister, engaged in conduct which was likely to diminish public confidence in the legal profession or in the administration of justice or otherwise bring the

legal profession into disrepute, in that between 2010 and 2013 he conspired to defraud by supplying false documentation to a number of people for the purposes of obtaining visas from the Home Office, for which conduct on the 16 November 2018 he was convicted at Southwark Crown Court and sentenced to 30 months imprisonment.

Mr Uddin, an unregistered barrister, failed to be open with his regulators when he did not report promptly, or at all, that he was charged with an indictable offence.

Mr Uddin, an unregistered barrister, failed to be open with his regulators when he did not report promptly, or at all, that on the 23 November 2018 he was convicted of a criminal offence.

Sanction: Disbarred. Cost to be paid to the BSB of £1200 within 3 Months. BSB not to provide a Practising Certificate if applied for.
